Payment Terms Credits are paid by direct credit on the Thursday immediately following the issuing by TGF of the fortnightly Supplier Statement. Debits will be deducted by direct debit, usually on the Friday immediately following the issuing by TGF of the fortnightly Supplier Statement. The completed direct debit authority must be in TGF's possession before the account becomes operative and the dishonouring of any payment may result in credit facilities being withdrawn. By submitting this application form the supplier irrevocably authorises that: TGF can issue Buyer Created Tax Invoices ("BCTI) in respect of all consignment supplies; The supplier will not issue tax invoices in respect of these supplies; and Upon the supplier providing their GST number to TGF they acknowledge that they are GST registered and will notify TGF if they cease to be registered. A late payment fee may be charged on all overdue accounts. This is presently set at 15 % per annum and is subject to change at any time at the discretion of TGF. If the account is inactive for over a period of 6 months, TGF may close the account. The supplier shall pay or reimburse TGF for all costs and/or expenses incurred by TGF (including court and solicitors costs) in recovering or attempting to recover any amount owing by the supplier to TGF. If this application for credit indicates that the supplier is a legal entity or a trust and that entity does not exist, any person(s) signing the application for credit shall be personally liable to TGF for all amounts that would have been owing by the legal entity or trust had it existed.
